

UNTIL FURTHER NOTICE FROM THE GOVERNOR PER NJ EXECUTIVE ORDER 187, WE MUST FOLLOW THE GUIDELINES LISTED BELOW IN ORDER TO OPERATE A SAFE INDOOR SOCCER ENVIROMENT. WE ARE CURRENTLY ALLOWED TO BE AT 25% CAPACITY PER SPECIFIED AREA, WITH NO MORE THAN 150 PEOPLE IN ANY SPECIFIC AREA AT ONE TIME.

Health and safety are our priority. TTE/DSA Leagues take the health of our participants, families and staff very seriously. As our Winter Sessions approach and more programs move indoors, we are taking every precaution to ensure the safety of all participants, customers and staff. Occupancy will be limited to ensure social distancing. We are following CDC protocols for masks, available hand sanitizer, frequent facility cleaning and disinfection, and measures to limit contact with surfaces.

TTE/DSA Leagues Protocols

In line with the CDC, TTE/DSA Leagues have adopted the following guidelines for programming. While the guidelines reflect the best practices and recommendations suggested by the CDC, they cannot fully prevent or mitigate the spread of the disease. Following these protocols is essential for the safety of our operations, and those who do not comply may be asked to leave the facility without return of any fees. These guidelines will be updated as needed.

Facility

- Every person who enters our building will be temperature scanned.
- Every participant/coach who enters the building must complete a COVID-19 Symptom
 Checker (http://questionnaire.totalturf.net/) and Waiver Form
 (https://tms.ezfacility.com/OnlineRegistrations/Register.aspx?CompanyID=2619&Group ID=27534520. These will be required for every.participant/coach must pay a \$7 one-time fee for increased staff, cleaning services and supplies for daily sanitation.
- There is a copy of the TTE COVID-19 Preparedness Plan for your reference at www.totalturf.net.
- During each visit to TTE, every participant/coach/visitor MUST complete a brief COVID-19 Survey.
- Social distancing is required inside and outside the facility.
- There will be separate exit routes for all turf fields and futsal courts. No one is allowed to exit through the main entrance.
- TTE facility will not be live streaming games.

League Safety Adjustments

- To avoid large crowds entering & leaving the facility, there will be staggered start times for games.
- There will be a 15-minute gap between games to allow more time and space for teams entering & exiting the facility.
- Teams will not be permitted to enter the building until 15 minutes before their game time. Teams must wait outside of the facility prior to the 15-minute pre-game point to avoid crowds gathering inside the building.

Parent Attendance & Observation during Leagues & Classes

- Only teams & coaches are permitted in the building during league games & skills classes. This is a result of the NJ Governors mandate on maximum capacity. If the state of NJ increases the number of occupants, we will adjust this rule accordingly. The only exception is for participants that are age 10 & younger. Participants 10 yrs old and younger may have 1 spectator per participant. (Changed per Gov Murphy 11-16 new mandates)
- No spectators will be allowed for participants of the TTE/DSA Leagues or skills classes
- Please reference the facility map below for a better understanding of how foot traffic will flow to/from the entrances and assigned exits.
- A cell number for all participants & coaches for contact tracing is required, if applicable.

Personal Protective Equipment (PPE)/Masks

- All participants, coaches, staff and visitors <u>are required to wear masks</u> when in or near the building. The choice of mask is at the guardian's/participant's sole discretion.
- While not required, it is permissible for participants continue to wear a mask while playing in their league game/ skills class. An exception may be made if a player has been advised not to wear a mask while exercising because of a specific health risk.

Ventilation

- TTE/DSA Leagues has a state-of-the-art ventilation system to help circulate outside air throughout the facility.
- TTE has extremely high ceilings which provide an environment conducive for indoor air circulation.
- Industrial exhaust fans will be running at full capacity at all times. The fans, combined with the extremely high ceilings found throughout the buildings, will promote the air circulation in the buildings in accordance with the CDC and EPA recommendations for COVID 19.

Sanitization

• TTE/DSA Leagues will have designated staffers for cleaning/sanitizing equipment and frequently touched surfaces. The facility will be thoroughly cleaned/sanitized each evening and as needed.

Social Distancing

- Social distancing rules are required in and outside of the building.
- In areas where lines/queues are required, spacing stickers on the floor/ground must be observed

Illness

- If a participant or staffer is diagnosed with COVID-19 or is quarantined because of a suspected diagnosis, all participants will be notified.
- Any participant exhibiting symptoms of any acute respiratory illness, a fever of 100.4°F, or is otherwise sick, must stay home.
- Participants must stay home if **any member of their household** exhibits the symptoms listed above.
- If a participant or any member of their household has had known exposure to a person with a COVID-19 diagnosis, you must immediately notify TTE/DSA Leagues. All participants and staff who have been in contact with the exposed participant will be notified immediately.
